Party Affiliation and Public Expenditures: Close-Race Evidence from French Municipalities - September 2022

· Do elected politicians use public money differently depending on their ideology? When is partisanship most apparent during a mandate? The existing literature is mixed. Based on a regression discontinuity design, I show that political color significantly impacts public spending in French municipalities. Moreover, partisanship mainly influences public expenditures in the last two years of the mandate, thus following a political cycle. Focusing on city size heterogeneity, I show that left-wing mayors invest substantially more than their right-wing counterparts in both small and large municipalities but in different spending areas. In contrast, differences in current expenditures concern only small municipalities. These findings highlight that city size and density may explain the conflicting results in the literature.

Racial and Gender Discriminations: Large-scale Evidence from French Local Elections - December 2022

· Do all citizens have an equal opportunity to be elected? Using an onomastic classifier and gender data of candidates for municipal elections in France, I causally estimate the effects of discrimination with a doubly robust AIPTW estimator and causal forests. I find that women lose about two percentage points compared to a male candidate, while people of Arab-Muslim origin lose about ten percentage points compared to a non-Arab candidate. These results highlight the strong presence of taste-based discrimination.

Airbnb in the City and the Country Challenged by Covid-19 - November 2022 with Marie Breuillé, Camille Grivault, Julie le Gallo, Yuheng Ling

· We analyze the determinants of the supply of short-term rentals through the activity of the Airbnb platform in metropolitan France. Through partitioning the territory in cities' attraction areas, we highlight a substantial spatial heterogeneity, with very attractive centers, while secondary poles are not

in demand. The Covid-19 crisis caused listings to drop between 10.3% and 13.5%, although the effects varied depending on the type of area. It has significantly affected central municipalities, main hubs, and municipalities outside city attraction areas but has not significantly impacted secondary centers and surrounding areas.
